



PRESENTATION OF CANDIDATURES

- The deadline for the submission of candidatures ends on **October 24, 2018 at midnight (Argentina time)** – art. 9^o n^o 1 E.R.
- Applications must be submitted by email to the Secretary-General to infopresident@fifcj-ifwlc.com
- The candidates must indicate the position for which they are applying – art. 10^o n^o 1 E.R.
- **The candidates for the positions of President, Vice-President, Secretary-General and Treasurer must submit their nominations to the Council** – art. 10^o n^o 2 R.E.
- The candidates for the position of President must also indicate the name of their mandate– art. 10^o n^o 3 E.R.
- **The candidates for the positions of President of the General Assembly and Secretary of the General Assembly and President of the Committee on Budget Control and Secretary of the Committee on Budget Control can not be candidates for the Council** - art. 10^o n^o 4 E.R.
- The candidates must provide proof of the payment of their membership – art. 8^o n^o 6 E. and art. 10^o n^o 5 R.E. Individual members must prove the payment of their contributions to FIFCJ. The other members should proof the payment made by their association.
- If as member of the Council, the candidate did not personally attend any Council meeting during the term before the election, she must send a justification letter to the Bureau, so that her candidacy can be admitted – art. 19^o n^o 3 E and art. 11^o n^o 1 E.R.
- If the candidate receives a notification from the Electoral Commission, in connection with art. 13^o n^o 1 E.R., she may regularize her candidacy according art. 13^o n^o 2 E.R.
